### Recovery – NPA walk

Our rapid response team, on the morning of July 5<sup>th</sup>, was mingling with 150-odd walkers as they surged up from Kathner Street for a look at fire-damaged Chapman and the recovery taking place in near-by bushland. Gösta stayed with the leaders, Reet and Janice moved within the body of the group, while past member Anne and I tailed the stragglers who elected not to climb to the high points, urging them to at least look at the view above Titheridge Place. But the mist hadn't risen. On Cooleman Trig Elizabeth was waiting to point out the returning plants, and on Mt Arawang Tony described the progress of the fire. Stage 1 of the walk ended with morning tea at the Kambah Fire Station where Anne and I caught the Salvation Army's shuttle bus back to Kathner St. The walk continued over Mt Taylor (still in thick mist) to a BBQ at Athlon Drive. Stage 3 took in Farrer Ridge.

The Recovery Centre, NPA and Salvation Army ran a very smooth operation. ☼

## Monitoring the Old Dam

Doug reports:

*One thing with a closed system, change is limited! Perhaps the greatest change over the last few months has been the temperature. Water temperature in July has dropped to 5.5 degrees Celsius from 17 degrees Celsius in April. This may explain the lack of algae where once the plumes were obvious.*

*While the dam is very murky, salinity is quite low and in July's test, no phosphates were detected. The water appears to be slightly alkaline. The level remains very low with no runoff from rain in the first part of the month.*

*Although water quality is dubious, a veritable squadron of ducks used the dam while we were testing. These could have been the ducklings, now grown, observed on the water a couple of months back. Wherever they're from, it's encouraging to see them.*

*Of course the sunflower, millet etc. shot from seed put out for wild life after the fire is still there. It's looking a little bedraggled with the cold weather but, combined with the abundant Paterson's Curse interspersed around the dam, things could get ugly in Spring. We may need to think about a work party to clean up the area. ☼*

## Park Care Coordinators' Meeting

More from Doug:

*Representatives of Park Care groups meet regularly with Steve Welch, the Environment ACT Park Care Coordinator. The July meeting was addressed by a member of Environment ACT's Water Resources Taskforce. In addition, Paul Higginbotham, who is responsible for the East district of Canberra Nature Park outlined developments on repairs to fencing and walking trails. A draft policy for sustainable water resource management in the ACT was launched by the ACT Government in July. It's a big issue and one all of us will confront as we are encouraged or coerced into a 12 per cent reduction in per capita use of potable water over the next 10 years – and a 25 per cent reduction by 2023 (on top of the 20 per cent already achieved since 1993). The draft goes into the options available, some of which include increased use of effluent, limiting stormwater flows and reducing household usage.*

*As to activities in fire-damaged areas of the Nature Park, Urban Services has taken the opportunity to enhance fencing of management trails. Some fences have been removed (one above Lincoln Close has gone) but others extended. The net effect on Cooleman Ridge is that the management trail resembles a corridor of wire – mainly to keep horses, bikes and other vehicles on the road and off the ridge. The Parks people are well aware of the looming explosion of weed growth. Extra funds were made available in the ACT Budget to deal with the problem and work is expected to be undertaken when growth commences in Spring.*

*Urban Services is also accelerating fire fuel reduction in non-burnt areas and managing buffer zones around houses. ☼*
