Eight members came to the Park Care activity for June and, although we were rained off half-way through the afternoon, we had walked far enough around Mt Arawang to see how well our trees were doing and to be pleasantly surprised at the small number of weeds we found (excluding grasses).

Thank you to the people who have returned their caretaker's reports to me; if you haven't yet done so please send them round soon. On filing them I realized that I had 10 reports for some areas, which means that they have been looked after for 5 years, what a difference there should be now! We are continuing to whipper snip along the horse trail on Wednesdays, although the grass is sprouting again it is much easier to cut the second time.

You may have read of plans to scrap the GangGang logo. The information we have is that they are planning to submerge the Act Parks and Conservation Service into the Department of Urban Services. 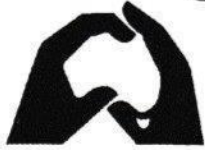

The primary role of the Unit is to promote partnerships that enhance and support community awareness and participation in caring for the environment.

As the ACT Community Landcare Coordinator, I will be focussing on;

- Identifying, sourcing and communicating information and skills, improving the exchange of ideas, and helping to raise public awareness in a variety of ways.
- Supporting and liaising with Rural Landcare groups,
- Landcare Month,
- Landcare Awards,
- Weeds awareness campaign.

The aim of the Bushcare Program is to reverse the decline in remnant vegetation through measures which seek to protect and re-establish areas of vegetation. Kris will be concentrating on building partnerships between the community, non-government organisations such as Greening Australia, and the ACT Government.


