“Some residents at this end are concerned at the lack of community consultation about the clean-up after the fire and the apparent lack of a post-fire management plan. Consultation between Parks and the Parkcare group does not constitute community consultation since the Parkcare Group is in essence a special interest group and is not necessarily representative of the broader community” David (Lincoln).

“I'd like a better understanding of what Parks have in mind regarding weed control. Also what is the policy towards species to plant in future? How can parkcarers be used to implement, follow up/report on weed eradication programs? Are we wanted or do we just get in the road?” Doug. ☼

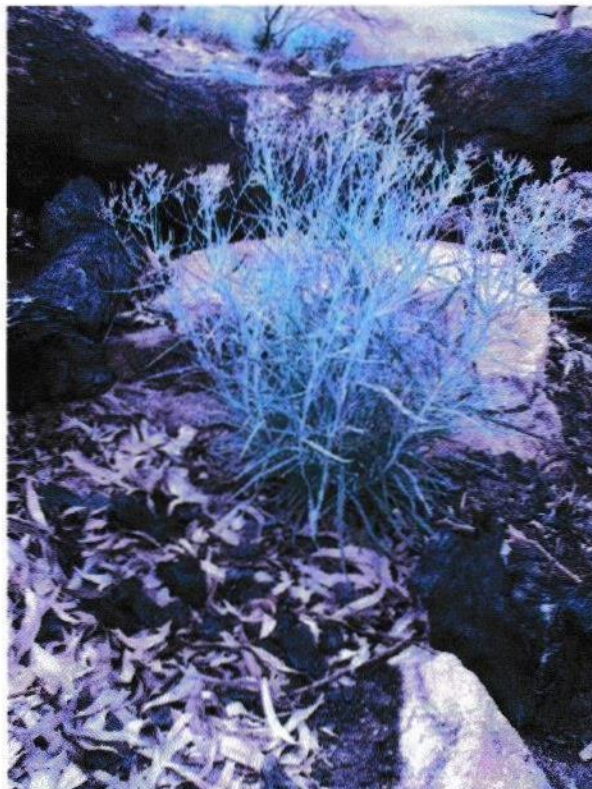
## What's around

ASTERACEAE – aster Gr. star. Previously Compositae; the daisy family



*Gnaphalium sphaericum*

Erect annual native herb 5-50 cm  
*gnaphalion* Gr: woolly , *sphaera* Gr: globe ☼



*Senecio quadridentatus* – Cotton Fireweed

Erect or ascending perennial native herb. Grows  
in disturbed areas especially after fire  
*senex* L: old man, *quadri* L: 4, *dens* L: tooth ☼

### Environment Protection

Every 5 years the Legislative Assembly reviews the rules and the offices concerned with Environment Protection. Many of those attending a workshop preparatory to the writing of a background paper were concerned with protection from the environment (poisoned air and water, restricted building codes etc.) but we think of this as an opportunity to discuss protection of the environment, in particular our Nature Park. So, we are making a submission that has to be lodged before end of January.

Our main points are that the Environment Protection Agency must be independent of political pressure and that it has to act according to best scientific advice at the earliest opportunity whenever a threat is perceived. The obvious example is the continuing threat of cattle grazing on Coleman Ridge which constitutes a real ecological danger without achieving its stated purpose of reducing fire danger for the Chapman residents. Both scientific expertise and independence from political knee-jerk reactions are important.
