

Previous Sunday Meeting, December 17th

From Janice comes a report that brings us up to date with the group's activity.

There were six souls who enjoyed the cool morning air to weed in the central Group Area. The area is looking good with fewer weeds (perhaps as a result of the drought). However, the shorter grass at this time revealed large numbers of verbascum, many in flower, that were determined to grow regardless of the lack of rain. We spent a couple of hours pulling out hundreds of fledgling plants. Hopefully this will help to reduce the size of the next crop when it rains.

Malcolm joined us on his walk across the Ridge recording the positions of, and dealing with, pine seedlings. The pine identified in the central area has been dealt with.

We noticed that the briars in the central area had been sprayed (not cut and dabbed). I am not sure who did this but it appeared to have been a recent activity. The spray had not had any affect on the briars at the time of the December meeting. •




DRAFT: TOWARDS A MANAGEMENT PLAN FOR COOLEMAN RIDGE CANBERRA NATURE PARK (continued)

AIMS AND OBJECTIVES

The Ridge is reserved as Public Land (Nature Reserve). Management objectives (ACT Parks and Conservation Service 1996) for the Ridge (and other similar tenures) are to:

- (i) conserve and enhance native plant and animal communities;
- (ii) conserve features of cultural, geological, geomorphological and landscape significance;
- (iii) maintain ecological processes;
- (iv) provide and promote appropriate recreation and tourism opportunities;
- (v) provide and promote a range of opportunities for raising awareness, appreciation and understanding of natural and cultural heritage;
- (vi) protect the area from the damaging effects of fire, erosion, pollution, pest plants and animals or other disturbances; and
- (vii) ensure appropriate practices by other agencies carrying out works in or adjacent to Canberra Nature Park.

A contractor sprayed most of the woody weeds on and around Arawang and for a way north in early December or late November. I remember seeing him as I went down Namatjira/Sulwood one morning around that time. It will be interesting to see the effect on the briars et al. From my observations there was no attack by the sprayer on the verbascum in the area, except by accident.

Mynas

Bill Handke (Canberra Indian Myna Action Group) writes:

October and November trapping data

Trapping in October and November in the Canberra region has seen a further 1715 Indian Mynas removed, giving some relief to native birds. This brings to 7085 mynas that have been trapped in this area.

CIMAG members have reported that Eastern Rosellas and Crimson Rosellas have been nesting in nest boxes and neighbourhood tree hollows for the first time in many years following the reduction in myna numbers in their local area as a result of trapping. This is very heartening news — although at the same time other CIMAG members are reporting that Indian Mynas have been keeping parrots from tree hollows in their area and in the reserves.
